

President's Corner, Karl T. Weber, MD



Council members, representing the SSCI, S-AFMR, SSPR and SSGIM came together on June 13, 2011 at our annual mid-year retreat, which was held in Memphis, home to rock 'n roll and birthplace to rhythm and blues. The meeting covered a wide range of topics, including several novel initiatives underway in 2011.

First, the SSCI-Sponsored Visiting Professors Program.

The SSCI mission statement indicates its dedication to the advancement of knowledge, information and ideas, together with a commitment to mentoring future generations of medical investigators and promoting careers in academic medicine.

The faculty embodied in SSCI membership represents an academic resource--- a book of knowledge. In 2011 and in keeping with its commitment to mentoring, the SSCI will launch a Visiting Professors Program. Its speakers bureau will consist of members, who are senior clinician scientists representing the very best of the various disciplines in internal medicine. Its purpose: to share knowledge with others.

Based on official applications submitted by an academic medical center to SSCI Council and its VPP Committee, SSCI faculty would be invited to deliver one or more lectures, including medical grand rounds, and to participate in other scholarly activities sponsored by the division or department for their

trainees and junior faculty. SSCI funds have been set aside to cover travel expenses; however, no honoraria will be provided for the privilege of representing the SSCI. More information can be found on the VPP announcement.

Second, a Pathophysiology In Medicine Series in The American Journal of the Medical Sciences.

Our annual scientific meeting is the flagship forum of the SSCI, where incremental knowledge and dialogues can spawn an interdisciplinary perspective in search of common pathophysiologic expressions of diseases and disorders. Thinly veiled barriers between disciplines can be easily torn down and replaced with refreshing and invigorating discourse between disciplines.

And what applies to our annual session should also hold true for the pages of our torchbearer, *The American Journal of the Medical Sciences*. In that spirit of cooperation and invigoration and with the endorsement


of editor, David Ploth, a new series entitled *Pathophysiology in Medicine* will be launched this fall with Karl T. Weber as series editor. Its objective to present cutting edge insights into pathophysiologic expressions of a disease or disorder, spanning subcellular and cellular levels and meticulously woven into a fabric that includes integration and organ- based physiology and importantly clinical medicine. Senior clinician scientists will be invited to present topics on which they are a nationally-recognized opinion leader. These reviews will appear in *The Journal* on a regular basis, where they will serve as a state- of-the-art resource to students, trainees and faculty.

Thirdly, the SSCI has released its **official logo**. It is available as lapel pins and neckwear and can be worn to display our pride and support of the Society. Merchandise can be purchased through our website and at the annual meeting.

Finally, plans are underway for the SRM annual scientific session, February 9- 11, 2012, in New Orleans. The **President's Symposium** on Friday morning will feature 3 outstanding clinician scientists addressing *The Heart Failure Epidemic: New Insights and Strategies*.

On Saturday morning, the **Joint Plenary Session** will feature another national epidemic: *The Cardiometabolic Syndrome: Hypertension, Obesity and Diabetes*. Senior clinician scientists will share their insights gleaned from the bench and the curbside into this all- important health problem afflicting children and adults.

In closing, let us the members of the SSCI explore our creative potential as we pledge to advance knowledge, ideas and information, to mentor future generations of biomedical investigators and to develop programs that support and indeed promote young clinician scientists. Exceptionalism is within our reach, let us explore it together.

Nephrology Young Investigators' Forum

The Eleventh Annual SSCI Nephrology Young Investigators Forum will be held on Wednesday, February 8. Information on this Forum can be obtained from the SSCI website www.ssciweb.org.

Abstract deadline for this Forum is October 14th, and is limited to Nephrology fellows.

SSCI Young Investigator Awards

The SSCI Young Investigator Awards are offered to recognize and encourage excellence in investigation by physicians and medical students during research training.

Eligibility: Medical students, combined MD/PhD students, interns, residents and post-doctoral physicians who are in research training or were in research training June 2011 are eligible. Post-doctoral research training may be considered to extend for a period of up to three years and time spent in strictly clinical fellowships need not count against this. The applicant must be the

first author of the abstract submitted in competition for the award and will plan to present the paper during the scientific sessions of the Southern Regional Meetings. Please note that it is not necessary for the senior author to be a member of the SSCI.

Procedure: Abstracts will be submitted for the 2012 Annual Meeting of the Southern Society for Clinical Investigation according to the usual procedure described in the instructions on awards consideration accompanying the abstract form.

Deadline: The submission deadline of the abstracts and application for the SSCI Young Investigator Award is **October 14, 2011.**

****Please note that nomination letters from the senior investigator or mentor and the Division Director or Department Chairman are required and should include a statement of the candidate's role in the study. In order to be eligible for consideration of these awards, the nomination letter(s) should be uploaded on the website at the time of abstract submission.**



The website committee has enacted several changes to the website since last year, when the look and feel of the site was improved. The goal of these changes was to make the work of committees and meeting-related activities run more smoothly and to increase communication with the membership.

On the main page, the President's letter is available with the eSSCI Newsletter. The logo has been updated. When members login, they can obtain SSCI and committee-related documents under a new "my files" link. Biographies can be updated, and members can volunteer to be meeting mentors for trainees at that time. Members can update how they would like to be notified of events, particularly those relating to the Southern Regional Meeting. You can now

receive updates by SMS, Twitter, or Facebook. On the administrative side, changes can be made to committees without involving a website administrator. The SSCI office can now add scrolling news items to the upper banner. Members who have not logged in and changed their biography will now be automatically notified. We hope that you will find these changes useful, and the committee welcomes feedback on the site.

SSCI COMMITTEE UPDATE (continued):

Finance Committee

The Finance Committee has met several times during the year reviewing financial metrics of the organization. As a whole, the SSCI is financially stable. Comparing FY 2009 with close of FY 2010, the SSCI witnessed a moderate increase in revenues (mostly derived from dues and meeting income) but increased expenditures. The success of the Southern Regional Meeting and our Awards program explain the majority of the expense increase. At the close of FY10 (December, 2010), we had a modest profit of \$22,164 and our

account balance rose to \$437,289. As of May 31, 2011 FY11 looks very similar. We have a net income of \$3500.

The Southern Regional Meeting (SRM) continues to prosper, although expenses have grown while revenues have been flat. The Committee has made several suggestions to Council to augment revenue for the meeting and to contain some of the expenses. At the 2011 SRM, 701 registrants joined us for an outstanding meeting making this the highest attended meeting since 1994 representing nearly 150 institutions. There were also 602 abstracts presented at this year's meeting. This represents a significant increase over

the preceding 5 to 6 years. Finally, we welcomed a number of new members to the SSCI.

The Finance Committee also discussed the long term financial stability of the SSCI, especially at a time where educational grants and industry support has been challenging. The SSCI has excellent operating reserves large enough to cover more than 12 months of expenses. In addition, the *Journal* continues to be financially strong and the Committee has recommended to Council that some of our cash reserves be invested more aggressively.
